

# ***Cedar RV Park & Car Wash***

## Park Guidelines and Expectations

Applicable to all RV Park/Campground Areas, Cabin, and RV Rental Units

*These Park Guidelines and Expectations are not all-inclusive but are based on the principals of mutual consideration and respect that are expected to be practiced between the Cedar RV Park Owners/Management, Guests, and Visitors. The citation, application, enforcement, and modification of the below Guidelines and Expectations is at the sole discretion of the Cedar RV Park Owners/Management.*

1. Cedar RV Park reserves the right to provide occupancy or services at their sole discretion.
2. Check-In time is 1:00 PM. Check-Out time is 12:00 PM (noon) Pacific Time. We will strive to accommodate any desired arrangements for early arrival or late checkout in advance of your arrival or departure.
3. All RV's and vehicles are expected to present a clean and satisfactory appearance and must be properly licensed and operable for the duration of their stay at the park. If you must make repairs in the site, please contact the office first.
4. Quiet hours are 10:00 pm to 7:00 am. Please be considerate of your neighboring guests at all times.
5. Please no washing of RVs or vehicles in the campsites or parking areas. May we suggest using our car wash!
6. Children are welcome at the Park. Please keep an eye on them and ensure that they conduct themselves safely while in the Park.
7. Dogs must be leashed at all times when outside of an RV, tent, or cabin on the premises. Please potty your dog in designated areas away from RV/camp sites and immediately clean up after them. Failure to clean up after your pet, or dogs that bark excessively or exhibit aggressive or menacing behavior can result in the owners being asked to leave without refund.
8. Dogs are allowed in the Cabin or rental trailers only with the pre-approval of the Owners/Management.
9. Please follow the posted notices in the laundry room. Washing of dog beds, heavily soiled or oily or greasy clothing, or oily shop rags is NOT allowed.
10. Visitors of RV Park or Cabin guests must check in at the Office. Use of the shower facilities, trash dumpster, or RV dump station by visitors of registered guests is subject to payment of the appropriate fees.
11. Please do not block the entrances and exits to the car wash. When in doubt as where to park your vehicles, please contact the Office.
12. No fireworks or discharge of firearms, air-powered firearms, bows, crossbows, blowguns, or slingshots in the park at any time.
13. Wood campfires are allowed in designated firepits only, and only when burn bans or red flag fire conditions are NOT in effect. Self-contained propane fire pits are allowed in any camp site. Please ensure wood fires are extinguished before leaving the firepit unattended.
14. Please exercise extreme caution and proceed at safe speed when driving in the park. This includes operation of ATVs. Pedestrians always have the right-of-way. Be alert for children.
15. Please no fish cleaning in your camp site or the restroom facilities. Suggest you field clean them and securely bag the entrails for proper disposal. Game animals must be field dressed before returning to camp. Field dressing and disposal of entrails or body parts is not allowed in the RV park. Hang, skin, and butcher game only in designated areas.
16. During winter weather, the use of chemical deicers and salt on concrete pads is discouraged. These may cause concrete to break down and permanently disintegrate. Please DO contact us if you need assistance with keeping the path to your RV safe.
17. Wild animals including deer, bear, cougar, and turkeys are regularly seen in and around the park. Please ensure pets are leashed and under your supervision and control at all times and ensure any food items kept outside are stored appropriately.
